# IZULU WATER - VOLUNTEER RULES

As we run an eco-friendly camp that is powered by solar and our own water comes from a borehole, our volunteers should be environmentally conscious about electricity and water. Since we practice garbage separation, please throw the garbage into the designated trash cans.

1. Alcohol and drugs is absolutely forbidden at Izulu Water.
2. Smoking is permitted outside of any building.
3. Loud music and any noise must stop at 9 pm.
4. When leaving the Bungalows - all doors and windows must be closed. Each person is responsible for his own possessions.
5. Respect your apartment and when you leave, leave it as found. This also applies to the communal areas, such as the kitchen, laundry room, game room etc.
6. Volunteers may not enter another bungalow without permission from the resident.
7. The volunteers may not drive the management or staff's cars without permission.
8. People and animals within our residential community and outside must be treated with respect and friendliness at all times.
9. The volunteer will at all times respect the laws and cultures of this country.
10. It is forbidden to feed our animals as this creates bad habits and is of course not healthy for them.
11. Physical injuries and any illnesses are your own responsibility but must be reported to management immediately so that the necessary arrangements can be made to receive assistance as soon as possible. (medication, doctor, hospital).
12. Should conflict arise, Volunteers must bring this to the attention of Management immediately and Management will attempt to resolve the problem as soon as possible.
13. In the event of any serious violations of our rules - Management reserves the right to send a volunteer home without refund. Example: aggressive behavior toward people and animals, possessions or buildings.
14. The volunteer also has the right to terminate this contract at any time, but without reimbursement.
15. The volunteer agrees that all photos and videos in respect of Izulu Water activities etc may be published on Face Book and our websites.
16. Specific area rules are as follow:
  - **Kitchen:** all utensils and items used must be cleaned and returned to the designated places. If any items are borrowed such as glasses, cups etc., these must be cleaned and returned as soon as possible. If anything is broken please report to management immediately. Please use the laundry powder efficiently and as directed. After use please ensure that everything is cleaned and left that way it was found.
  - **BBQ area:** No open or unattended fires are allowed, all fires must be controlled in the fire pits supplied. Fires in BBQ's or fire pits must be extinguished if not attended or before going to bed at night.
  - **Outside Areas and Swimming Pool:** ensure that all garbage is placed in the bins provided, no bottles, towels and clothing etc to be left lying around. No glass in or around the swimming pool as it cannot be seen if broken and can cause injuries.
17. The volunteer need to bring with them a Travel Insurance.

# IZULU WATER - INDEMNITY

I understand and agree that neither IZULU WATER, including the owners, officers, employees, agents, dive professionals, nor the vessel owner, nor the vessel, or assigns of the above listed individuals and/or entities (hereinafter "Released Parties") may be held liable or responsible in any way for any injury, death, other damages or any other loss to me, my family, estate, heirs or assigns, that may occur as a result of my participation in this Activities or as a result of the negligence of any party, including the Released Parties, whether passive or active.

I understand that all Activities may be physically strenuous and that I will be exerting myself during this Activities, and that if I am injured as a result of heart attack, panic, hyperventilation, drowning or any other cause, that I expressly assume the risk of said injuries and that I will not hold the Released Parties responsible for the same.

I further state that I am of lawful age and legally competent to sign this liability release. I understand the terms herein are contractual and not a mere recital, and that I have signed this Agreement of my own free act and with the knowledge that I hereby agree to waive my legal rights. I further agree that if any provision of this Agreement is found to be unenforceable or invalid, that provision shall be severed from this Agreement. The remainder of this Agreement will then be construed as though the unenforceable provision had never been contained herein.

**DIVING:** I hereby affirm that I am a certified diver (or a student diver under the control and supervision of a certified scuba instructor), and that I thoroughly understand the hazards of scuba diving including those hazards occurring during boat travel to and from the dive site (hereinafter collectively referred to as "Excursion"), which may result in serious injury or death. I understand that these hazards include, but are not limited to, air expansion injuries, drowning, decompression sickness, slipping or falling while on board, being cut or struck by a boat while in the water, injuries occurring while getting on or off a boat, and other perils of the sea. By signing this release, I certify that I am fully aware of and expressly assume these and all other risks involved in such an Excursion, whether conducted as a recreational dive or part of a diving class.

I understand and agree that I am not only giving up my right to sue the Released Parties but also any rights my heirs, assigns, or beneficiaries may have to sue the Released Parties resulting from my death. I further represent I have the authority to do so and that my heirs, assigns, or beneficiaries will be estopped from claiming otherwise because of my representations to the Released Parties.

WITH THIS AGREEMENT, I AGREE TO ALL OF THE ABOVE ARTICLES. IZULU WATER, INCLUDING ALL PERSONS WHO PARTAKES IN THE ACTIVITIES OR LEADS THE ACTIVITIES, ARE EXCLUDED FROM ALL LIABILITY AND RESPONSIBILITY FOR PERSONAL INJURY, PROPERTY DAMAGE, OWNERSHIP OR DEATH. I AGREE THAT IF MY NEGLIGENCE CAUSES DAMAGE TO MATERIALS OR BUILDINGS, I WILL BE HELD ACCOUNTABLE.
